I, Dr. Bonginkosi Emmanuel Nzimande, Minister of Higher Education, Science and Technology, in terms of Regulation 6 of Schedule A of the Regulations for the Protection of the Karoo Central Astronomy Advantage Areas, hereby extend the one (1) year compliance period for the KCAAA's Regulations by six (6) months, to allow licensees and licence exempt operators more time to comply with the provisions of the said regulations.
